#### SECTION 5: FIRE-FIGHTING MEASURES

**5.1 Suitable (and unsuitable) extinguishing media:**

If possible use polyvalent powder fire extinguishers (ABC powder), alternatively use foam or carbon dioxide extinguishers (CO<sub>2</sub>). IT IS RECOMMENDED NOT to use full jet water as an extinguishing agent.

**5.2 Specific hazards arising from the chemical:**

Due to its non-flammable nature, the product does not present a fire risk under normal conditions of storage, manipulation and use.

**5.3 Special protective equipment and precautions for fire-fighters:**

#### SECTION 6: ACCIDENTAL RELEASE MEASURES

**6.1 Personal precautions, protective equipment and emergency procedures:**

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. Personal protection equipment must be used against potential contact with the spilt product (See section 8). Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inertization agent. Destroy any source of ignition. Eliminate electrostatic charges by interconnecting all the conductive surfaces on which static electricity could form, and also ensuring that all surfaces are connected to the ground.

**6.2 Environmental precautions:**

**7.1 Precautions for safe handling:**

A.- Precautions for safe manipulation

Comply with the current standards 29 CFR 1910 Occupational Safety and Health Standards. Keep containers hermetically sealed. Control spills and residues, destroying them with safe methods (section 6). Avoid leakages from the container. Maintain order and cleanliness where dangerous products are used.

B.- Technical recommendations for the prevention of fires and explosions

Because the product is a flammable liquid, storage should meet the requirement of 29 CFR 1910.106, Flammable and Combustible Liquids Code. Transfer in well ventilated areas, preferably through localized extraction. Fully control sources of ignition (mobile phones, sparks,...) and ventilate during cleaning operations. Avoid the existence of dangerous atmospheres inside containers, applying inertization systems where possible. Transfer at a slow speed to avoid the creation of electrostatic charges. Against the possibility of electrostatic charges: ensure a perfect equipotential connection, always use groundings, do not wear work clothes made of acrylic fibres, preferably wearing cotton clothing and conductive footwear.
