5.1 Suitable (and unsuitable) extinguishing media:

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. 7.1 Precautions for safe handling:

A.- Precautions for safe manipulation

Comply with the current standards 29 CFR 1910 Occupational Safety and Health Standards. Keep containers hermetically sealed.
